## **Am I eligible for Pre-Junior Company?**

- Any dancer in 3rd grade or higher is eligible to be a part of Pre-Junior Company

## **The Studio Staff Expectations**

- Centralize all information through Google account
- Communicate through GroupMe
- Calendar of events
- Itineraries
- Packing Lists
- Communicate to parents and dancers a week in advance of any potential changes or new opportunities
- Will work around school/team/family schedules and utilize dancers that can participate to the best of our abilities

## **Dancer Expectations**

- Enroll in and attend the Pre-Junior Company Class (1 hour class)
- Dancer is required to enroll in Ballet level 1 or higher class depending on recommendations
- Positively represent The Studio School of Dance and Pre-Junior Company at all times
- Participate in all scheduled rehearsals, performances and additional events
- Be available to assist with registration, costume pick-up/picture days and any other leadership opportunities at The Studio
- Respect The Studio staff, visiting artists and fellow Pre-Junior Company members at all times

## **Family Expectations**

- Transport your dancer or carpool to all events
- Stay up-to-date and communicate to The Studio Staff via email/GroupMe

## **Performances may include**

- Holiday Showcase
- Charity Event/Community Performances
  - Recital

All dancers are expected to attend and perform at all events. In the event a pre-scheduled event or illness does conflict/impede attendance, another dancer will be selected and/or understudies will be used accordingly.
